## PARTICIPATION AGREEMENT AND WAIVER

The safety and well-being of participants and volunteers is our top priority, and we follow all professional and safety guidelines. There are guidelines that are necessary for you to follow as well:

- 1. Dress appropriately for the activity and the weather. Wear jeans or long pants, not too baggy or tight. Layer tops in cooler weather. Gloves, hats and rain jackets may be needed at times.
- 2. Wear boots or hard leather shoes with a low heel, and socks (No canvas or high heels) A horse may unintentionally step on your foot.
- 3. Helmets must be worn when riding; hair should be worn to accommodate the helmet (low ponytail).
- 4. No dangling jewelry should be worn during these activities.
- **5.** Cellular phones, electronic music players or games should not be *with* or *on* program participants.

This is an activity which provides many physical, emotional, social, mental, and spiritual benefits. As a volunteer or parent/ guardian of the minor named below, I acknowledge this and agree to my/ my child's participation in Heavenward Farm activities, which includes working with and around horses, working around the barn, loft, pastures, fencing, and equipment; riding, and participating in activities involving horses. I understand that there are potential risks as in any equine activity, including but not limited to, the following:

- The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals
- Hazards, including but not limited to, surface or subsurface conditions or loosening of the girth.
- The propensity of an equine to behave in ways that may result in injury, death or loss to persons on or around the equine
- The potential for misuse or malfunction of equipment, or accidental injury while using said equipment or tools.
- The potential of a participant to act in a negligent manner that may contribute to injury, death or loss to the person of the participant or to another person.

In consideration of the potential benefits and with full understanding of the potential risks, I hereby waive any and all claims against Heavenward Farm and Horsemanship, Horse *Power*, an X-treme Adventures ministry; City Gospel Mission; 3C Counseling & Consulting Services, LLC, Carole Bower, Robin Bower, or their successors, affiliates, directors, officers, employees or volunteers, for personal injury or property damage of any kind that may arise as a result of participation in equine activities.
